REQUEST FOR PROPOSALS DESIGN AND PERMITTING OF STEEP FALLS FIRE STATION

The Town of Standish is soliciting competitive proposals for a design team to design and secure permits for a 22 x 80-foot addition and modifications to the existing Steep Falls Fire Station located at 870 Boundary Rd. The proposed structure will provide office space, living quarters, and garage bay space. Included in this will also be upgrading the remainder of the buildings meeting space, bathrooms, and heating system. The Town intends to contract with a single entity that will be responsible for the coordination of a design team of professionals to complete the requested service.

General Comments

The services requested as set forth below represent the needs of the Town of Standish (here-in-after referred to as the Town). Any significant variation or omissions from these requests may be cause to invalidate the proposal.

This project is limited to the Steep Falls fire station, it is to be designed to meet current handicap, fire, safety and public access codes. It should meet the highest degree of energy conservation. All required permit application fees will be paid by the Town.

A conceptual floor plan entitled "Draft Floor Pan- Steep Falls Fire Station-12/12/16" is provided with this packet. The building is planned to be a one level connected to the south side of the existing building with 2 different roof lines. The Town plans to have the exterior siding and roofing of the new addition match the existing fire station. The building is to be designed with electrical updates to the existing building and it is anticipated that the HVAC system for the new building will include a replacement to the existing HVAC units in the station with expanded service to the proposed addition.


